Identification of test cases according to IVE output

- Worst case analysis
- Stress tests for software robustness
- Stability and reliability
- FIDIR analysis
- Interface testing etc. (Test Plan)

Construction of test procedures

- Automated test procedures
- Minimizing user intervention.

Execution of test procedures

- Validation findings
- Observations and problem reporting. (Test Report)
